### Methodology

To create the list, *Houstonia* contracted DataJoe Research to facilitate an online peer-voting process. DataJoe is a software and research company specializing in data collection and verification, and conducts various nominations across the U.S. on behalf of publishers. DataJoe checked each attorney against the Texas Bar Association database. If DataJoe was unable to find a lawyer's registration with the state bar, that lawyer was excluded, as was any lawyer who has been disciplined for an infraction. DataJoe then presented the tallied result to *Houstonia* magazine for final review and adjustments.

DataJoe recognizes many good and effective lawyers may not appear on this list. This is only a sampling of the huge array of talented professionals within the region. Inclusion is based on the opinions of responding lawyers. While DataJoe takes time and energy to ensure fair voting, the results of this survey are not an objective metric.
