

Our dedicated pro bono program helps ensure equal access to justice by all members of society. In 2022, Jackson Walker's biggest pro bono and public service success was the creation of new partnerships with legal services organizations to advance equity in the justice system, to address the COVID-19 pandemic, to help Texans affected by the February winter storm, and to support journalists who covered the election and vote counting in Texas. JW attorneys also receive 50 hours of billable credit for pro bono work.
